### **Detailed Description Of Goods And/or Services**

Besides receiving donations from the public we also make available various merchandise products and offer services to followers and members of the public as a way of raising additional funds.

### **1. Shipping/Delivery Policy**

Lindsay Dillman Ministries only does Shipping/Delivery Nationally throughout South Africa. All items are shipped door to door via [courier service of our choice](#).

#### **R100 Flat Shipping to all Major Cities/Towns:**

Durban, Pietermaritzburg, Johannesburg, Pretoria, Nelspruit, Bloemfontein, East London, Port Elizabeth, George, Kimberly, Cape Town, Stellenbosch.

- Subject to availability and receipt of payment, order processing takes 24 hours
- Packages arrive within 2-3 business days in major cities
- Packages arrive within 3-5 business days in outlying areas
- Your shipping will be calculated on checkout – this includes all outlying areas not listed above as major cities/towns.
- Subject to availability and receipt of payment, orders will placed on Fridays before 2.00pm are dispatched same day - orders received after 2.00pm on Fridays are dispatched on Monday.

**We offer free shipping on orders over R2500.**

- Store credit cannot be applied to future purchases until the return is processed. Meaning, you cannot apply the store credit before we have actually issued it to you.
- Items of the Day, Flash Sale and Sale Items are FINAL SALE!
- We do not hold items for returns or exchanges.
- Please allow 3 business days for return processing.
- Once your return is processed, we will email you an egift card with your store credit that you can use on the website.
- Preorders of backordered items may ship separately.
- Any returns past the policy will not be accepted or store credited.

#### **EXCHANGE POLICY / INCLUDING DAMAGED GOODS POLICY**

- Exchanges must be the same item.
- We are not able to exchange for different items.

If we have the item in stock, we will send it to you. If we don't have your item in stock, we will send you an egift card with store credit.

Card transactions will be acquired for Lindsay Dillman Ministries via PayGate (Pty) Ltd who are the approved payment gateway for all South African Acquiring Banks. PayGate uses the strictest form of encryption, namely Secure Socket Layer 3 (SSL3) and no Card details are stored on the website.
